In accordance with the shared services agreement, this report provides a summary of building, planning and environmental health matters for February 2024. This includes all activities, the progress of ongoing situations and concerns related to the required services raised by the Shire of East Pilbara.

Building

No Building Permit Applications have been received this month. We have provided advice to Shire staff in regard to carports to be built on Shire of Meekatharra owned land.

Planning

Planning information and advice was provided to the Shire of Meekatharra during April. This mainly involved the provision of information relating to a proposed road widening south of Capricorn.

Environmental Health

Health staff provided remote assistance during April -

- A section 39 certificate was issued to Sodexo to extend the outdoor licensed area at Bluebird Mine Village.
- Internal discussion raised about the proposed timeframe for the construction of the ablution facilities located at the BP truck stop, Connaughton St, Meekatharra.
- The wastewater system has been installed at 32 Hill St Meekatharra. Photos of the installation and certificate of compliance have been received and a Permit to Use will be prepared.
- Responded to a query from Fiduciary Administration Services regarding provision of quarterly ATU maintenance service reports.
- Processed a food traders permit for Lahore on Wheels who traded from the 25th April to May 1st 2024.

- Mid West Turf from Geraldton have been successful in the quote for 555m2 of Kikuyu turf. Delivery and installation has been postponed until the final Lions Park design has identified location.
- 4. Median Strip 'Meekatharra's Streetscape Art Project' Repair Works yet to be completed.
- 5. Lloyd's Signage

Still awaiting Main Roads WA comments on the latest sign proposal.

6. Picture Gardens

Awaiting final report from Council Health Officer (Shire of East Pilbara) regarding asbestos issues in both buildings. Issues also exist around the emergency exits front and back regarding the proposal to only rebuild the toilet block.

Councils Building Officer (Shire of East Pilbara) has provided information on required works, permits and demolition including of asbestos.
