In accordance with the shared services agreement, this report provides a summary of building, planning and environmental health matters for October 2024. This includes all activities, the progress of ongoing situations and concerns related to the required services raised by the Shire of East Pilbara.

##### **Building**

No new Building Permit applications have been received for the month of October however we were able to finally approve a Building Permit for a Shed at 83 Hill Street, Meekatharra. No other queries from Meekatharra staff this month.

##### **Planning**

One planning query was received during October. Advice was provided to the Shire regarding fencing requirements for a residential property at 86 Oliver Street, Meekatharra.

##### **Environmental Health**

Health staff provided remote assistance during October:

- Review of fire damaged Pensioners Units in Hill St Meekatharra in conjunction with Building Services;

- Assisted with food van trading queries in relation to Outback Festival Meekatharra;
- Cancellation of food business registration for Plutonic Village held by previous catering company;
