In accordance with the shared services agreement, this report provides a summary of building, planning and environmental health matters for September 2024. This includes all activities, the progress of ongoing situations and concerns related to the required services raised by the Shire of East Pilbara.

Building

We have received one new Building Permit Application this month. The application requires Planning Approval prior to Building Permit being lodged. Once a development application has been submitted, it will be assessed and if approved, Building will proceed with assessment of the Building Application. We have two queries this month regarding a Fight Night at the Capricorn Roadhouse and a new hospital and where required provided timely advice on these matters.

Planning

Planning advice was provided to the Shire of Meekatharra in relation to street numbering processes as well as clarification on the Form 15A process for 1011 - 1013 Oliver Street, Meekatharra.

Environmental Health

Health staff provided remote assistance during September:

- Comment was provided to Capricorn Roadhouse & Grill stating no objection to the granting of an Extended Trading Permit (Liquor Licence) for Newman Fight Night to be held Saturday 7th December.
- WACHS have approached Shire of Meekatharra regarding the potential for the upgraded Meekatharra Hospital to connect to the sewage ponds once construction is complete in 3 to 5 years. Shire to investigate this possibility including what would be required for the new Hospital to connect to the sewage ponds.
- The Shire has received a Section 39 application (liquor licence) from Meekatharra IGA Supermarket. An inspection will be conducted at next visit to Meekatharra proposed for December.
- A Local Government Report was sent to Department of Health for the wastewater treatment plant servicing the Andy Well mine camp.
